

Alternative Approval Elector Response Form Area 'D' Boundary Extension Proposal

I am OPPOSED to extending the municipal boundaries of the City of Campbell River southward to include a portion of Electoral Area 'D' of the Strathcona Regional District as shown on the attached map.

INSTRUCTIONS:

- If you are opposed to extending the municipal boundaries of the City of Campbell River southward to include a portion of Electoral Area 'D' of the Strathcona Regional District and you qualify as an elector of the City of Campbell River, you may sign this form
- If you are in favour of the proposed boundary extension you need to do nothing
- To sign an alternative approval process elector response form you MUST meet the following criteria for either a Resident Elector OR a Non-resident (Property) Elector:

I, the undersigned hereby certify that:

- I am 18 years of age or older;
- I am a Canadian citizen;
- > I have resided in British Columbia for at least 6 months immediately before signing this elector response form;
- ➤ I have resided in the City for at least 30 days before signing this elector response form;
- In the case of a Non-Resident Property Elector:
 - I am not entitled to vote as a Resident Elector in the City for purposes of this matter;
 - I have been a registered owner of real property in the City for at least 30 days before signing this elector response form;
 - I acknowledge that I may sign this elector response form on behalf of only one property that I own in the City;
 - If there is more than one individual who is the registered owner of the property, only one of those individuals may sign this elector response form in relation to the property, assuming the Non-Resident Property Elector has the written consent of the number of individuals who, together with the person signing this elector response form constitutes a majority of the registered owners.
- ➤ I am not disqualified from voting under the *Local Government Act* or any other enactment or otherwise disqualified by law from voting.

Note: You MUST reside or own property within the municipal boundaries of the City of Campbell River in order to sign this alternative approval process elector response form.

NOTE: A person must not sign any alternative approval process elector response form more than once and may not withdraw his or her name from the alternative approval process elector response form after the deadline for submission of the petitions has passed.

Signed elector response forms <u>must</u> be received by the City Clerk, Campbell River City Hall, 301 St. Ann's Road, V9W 4C7 by mail or in person, or fax to 250.286.5760, or email info@campbellriver.ca on or before 4:00 p.m. on Monday, July 21, 2014.

The number of eligible electors of the City of Campbell River is estimated to be 24,011. If 10% (2,401) of the estimated number of electors of the City of Campbell River sign an alternative approval process elector response form opposing the boundary extension, City Council will not be able to proceed without then receiving the assent of the electors by referendum.

Please note that regardless of what Campbell River electors decide, the boundary extension will not proceed if Area 'D' residents reject the proposal at their June 28, 2014 referendum.
